- 1) The meeting was called to order by J. Hunt @ 7:00 P.M.
- 2) The Pledge of Allegiance was recited
- 3) Roll Call: Members Present: J. Hunt, L. Hunt, A. Deater, J. Kibart, M. Stroven. Members Absent: None
- 4) Public Comment: a resident inquired about the date of the Dump Day.  
Dump Day will only be held once this year on Saturday June 13th,2026 from 8 a.m. until 2 p.m. or until full. We will have 4 dumpsters available because of the one time Dump Day.
- 5) The Agenda was approved as amended ( Old Business E. was added: special use permit,Austin Anson, with a motion by J. Hunt supported by L. Hunt I/F 5-0
- 6) The minutes of the regular board meeting and budget hearing of 3/9/2026 were approved as presented with a motion by J. Hunt supported by A. Deater I/F 5-0
- 7) The Treasurers report of March 31,2026 was approved as presented with a motion by J. Hunt supported by L. Hunt I/F 5-0.
  - a) Fund Balance:\$ 382,208.19
  - b) Restricted Balance: \$10,425.38
  - c) Balance Available for Township Operations: \$ 371,782.81
- 8) Old Business:
  - a) Flock Camera's: L Hunt gave an updated report about the Flock Camera System being installed by the Oceana County Sheriff's Department.
  - b) Election Workers: L. Hunt asked if anyone would work the August and November Elections or if they knew anyone that would. Help is needed.
  - c) Dumpster/Porta Potty at Taylor Bridge Landing: as discussed last month the dumpster is being abused( it is full of household items right now!) it will be removed soon.. A motion was made by J. Hunt supported by A. Deater to put in a Porta Potty I/F 2/3. The motion did not pass.
  - d) Blight Complaint: J. Hunt gave an update on the blight complaint against Richard Hoffman of 9049 E. Wilke Rd. Fremont,MI. 49412. He said he would get it cleaned up this year.
  - e) Noise Complaint: a resident that was issued a special use permit has neighbors complaining about the noise his business is making, the supervisor will follow up on this.
- 9) New Business:
  - a) A motion was made by J. Hunt supported by A. Deater to retain Gary Evans on the Planning Commission Board for a 3 year term. I/f 5-0
  - b) The board approved a salary reduction for the Zoning Administrator from \$ 5,457.44 to \$ 3,000.00 yearly at the meeting

of 3/9/2026 and with a motion by J. Hunt supported by A. Deater, Resolution # 2026-3 was adopted and Library Board members will be paid by the Hesperia Community Library at a \$30.00 Stipend instead of by the Township with Resolution # 2026-4 also being adopted. I/F 5-0.
